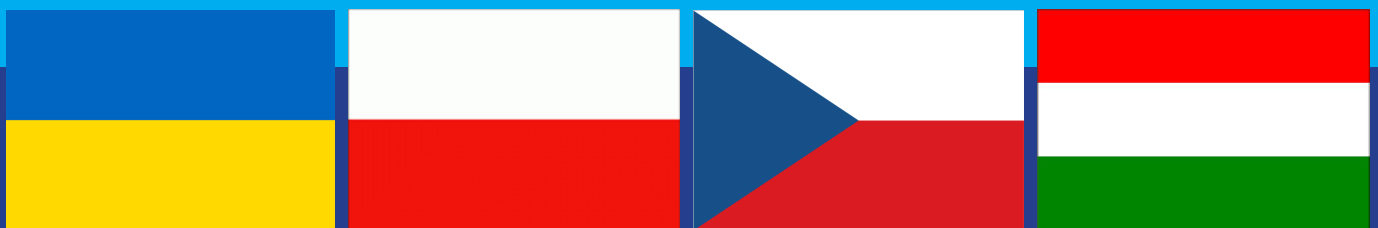

We invite you to participate in the international scientific and practical conference «STATE POLICY ON NATIONAL MINORITIES RIGHTS PROTECTION: EXPERIENCE OF VISEGRAD GROUP COUNTRIES»

The purpose of the conference is to consider different approaches to the implementation of the policy of protecting the rights of national minorities in Ukraine and Visegrad Group countries, to identify problems and threats in the implementation of ethnopolitics by modern European states, along with drafting recommendations to the governing institutions for their warning and prevention.

The Conference would be conducted on the basis of a multidisciplinary approach to provide an effective discussion platform for consideration key achievements and principal challenges in the field of protecting the rights of national minorities in Ukraine and in the EU states, in particular in the Visegrad countries, and would provide effective communication between scientific centres, civil society institutions and state authorities.

The objective of the conference is to highlight, test and popularize domestic and foreign researchers scientific achievements, to represent the best state practices in the field of national minorities rights protection, and to provide recommendations to state authorities taking into account the proposals of representatives of national minorities.

Representatives of scientific communities, civil society, state authorities, foreign states and international organizations, mass media, as well as all interested people are invited for the conference.

- ✓ The role of governmental and non-governmental institutions in the development of the ethnopolitics of the Visegrad Group and Ukraine in the post-bipolar period.
- ✓ Political and legal support of the activities and functioning of national minorities in the countries of the Visegrad Group.
- ✓ National and supranational standards correlation problem in the field of national minorities rights protection.
- ✓ Cultural and educational centers of national minorities in the countries of the Visegrad Group.
- ✓ Development of the contemporary state policy of Ukraine on the protection of the rights of national minorities.
- ✓ Contemporary global challenges and international cooperation in the sphere national minorities rights protection.

Working languages of the conference: Ukrainian and English.

The form of participation: full-time / part-time.

Registration of participants: June 18, 2019 at 10.00 am.

The term for sending an article to a collective monograph: until 20.05.2019.

THE COLLECTIVE MONOGRAPH'S ARTICLES WRITING REQUIREMENTS

- ✓ Articles may be submitted in Ukrainian, English or languages of the countries of the Visegrad Group
- ✓ The text of an article should be presented in Microsoft Word (format *.doc.).
- ✓ Volume of articles – from 22 to 25 thousand signs.
- ✓ Page format – A4, no numbering of pages, orientation - book.
- ✓ All fields – 20 mm.
- ✓ Font - Times New Roman, size - 14, line spacing - 1,5.
- ✓ Paragraph indent - 1,25 mm, alignment in width.
- ✓ The article should include a title, an abstract in English (up to 500 symbols) and keywords (up to 8 words).
- ✓ The references to the sources in the text should be given in alphabetical order in square brackets, indicating the source number and the page number with a comma: [1, p. 243]. When referring to the electronic source, only the number is given - [2], to several sources: [3, p. 28; 4, p. 63-65] or [1; 5; 10] or [1-5].
- ✓ The name of the file (articles) sent to the organizing committee should be the author's last name (the first author when the article is published in co-authorship).
