Requirements for conference papers

➤ Materials should be submitted as a .doc file attached to an email sent to conference.dtlc@gmail.com.

➤ Papers should not exceed 5 pages (recommended length: 3–5 pages). They must be formatted in Microsoft Word, font Times New Roman, 14 pt, 1.5 line spacing, margins of 20 mm on all sides, paragraph indent – 10 mm, paper size A4. Pages should not be numbered.

➤ In-text references should be given in square brackets: the first number indicates the source in the reference list, and the second number after the comma indicates the page. A reference list must be provided at the end of the paper in alphabetical order.

➤ On the first page, please indicate:

- 1) the author's (or authors') full name(s), academic degree, academic title, position, and affiliation (aligned to the right at the top);
- 2) the title of the paper – in bold, uppercase letters, center-aligned, with spacing before and after;
- 3) the main text – spaced according to the formatting requirements above.
